Herewith we confirm that our product ORAJET® 3174 has been evaluated under the EU REACH Regulation (EC) 1907/2006 (Registration, Evaluation, Authorisation of Chemicals) based on the materials in the product to the best of our knowledge the above product does not contain any SVHC's (Substances of Very High Concern) exceeding 0.1% of weight of the product.
